COLLEGE SCHOLARSHIP QUALIFICATIONS:

- Applicants must be a child, grandchild, or legal ward (guardianship) of an active voting member of the South Texas Justices of the Peace and Constables Association, Inc.
- Must be enrolled in a college or university in an academic course of study.
- Must be younger than 25 years of age.
- Must have completed at least one semester of college/university.
- Must have a cumulative grade point average of at least 2.5.
- Must complete scholarship application.
- Must have **not** been convicted of a crime, which would make an individual ineligible for employment in his/her field of study.
- Must submit with application a brief biographical sketch and a narrative, written in the applicants own words, stating why the applicant believes he/she is deserving of a scholarship award, including personal accomplishments, activities, and experiences, and may not exceed two (2) typewritten, double spaced pages in length.

HIGH SCHOOL SCHOLARSHIP QUALIFICATIONS:

- Applicants must be a child, grandchild, or legal ward (guardianship) of an active voting member of the South Texas Justices of the Peace and Constables Association, Inc.
- Must be a high school graduate.
- Must show proof of acceptance and enrollment of college that you will be attending.
- Must complete scholarship application.
- Must have a cumulative grade point average of at least 2.5 (75 GPA)
- Must have **not** been convicted of a crime, which would make an individual ineligible for employment in his/her field of study.
- Must submit with application a brief biographical sketch and a narrative, written in the applicant's own words, stating why the applicant believes he/she is deserving of a scholarship award, including personal accomplishments, activities, and experiences, and may not exceed two (2) typewritten, double spaced pages in length.
